## RULES AND DETAILS FOR DROPPING OFF MATERIALS

1. Please pull up to the scale house so they can direct you to the correct tipping location.
2. You must provide information on the city where the materials came from.
3. Properly load (distribute weight evenly) and cover your load with a tarp to prevent waste from blowing away during transportation. There is a \$30 fee for loads not properly tarped per California Vehicle Code.
4. There is a minimum fee of \$70 for offloading assistance from facility staff.
5. Fees depend on the type and amount of material you are dropping off. Visit our website for current pricing: [www.uvds.com/clover](http://www.uvds.com/clover)
6. Vehicles larger than 10 yards or materials such as logs, pressure treated wood, wood chips, or scrap metal will be weighed and charged per ton.
7. Vehicles less than 10 yards that do not contain the materials listed above, will be charged by the yard.

### SEPARATE YOUR MATERIALS TO SAVE MONEY!

- Many source separated materials like common recyclables and e-waste can be dropped off at no charge.
- Other materials that are mixed but separated from landfill garbage have reduced charges.

# ACCEPTABLE SELF-HAUL MATERIALS

## ORGANIC WASTE

### FOOD & FOOD-SOILED PAPERS

- Food waste: things like vegetables, fruits, meat, bones, fish, dairy, bread, rice, plate scrapings, spoiled food
- Food-soiled paper waste: things like napkins, paper towels, paper plates and pizza boxes, Coffee filters, wooden chopsticks



### LANDSCAPING MATERIALS

- Clean yard debris like grass clippings, leaves, branches, flower trimmings, and hedge trimmings
- Logs and tree sections



**IMPORTANT!**  
All organics must be separated from non-organic waste. It's the law! See back page for details.

## RECYCLING

### COMMON RECYCLABLES

- Clean Paper/Cardboard
- Aluminum/tin cans
- Plastic bottles & jugs
- Glass bottles & jars



### HOUSEHOLD DEBRIS

- All Appliances
- Bathroom fixtures (sinks, toilets, tubs, etc.)
- Mattresses
- Carpet and carpet padding
- Electronic items (E-waste)
- Tires



### CONSTRUCTION & DEMOLITION DEBRIS

- Sheetrock, plaster, tile, stucco
- Non-hazardous wood waste: things like unpainted, unstained, or untreated wood, & timber
- Concrete (with or without rebar)
- Asphalt
- Brick, dirt, or rock



## GENERAL REFUSE GARBAGE/LANDFILL

ANY MATERIALS THAT ARE NOT RECYCLABLE OR COMPOSTABLE.

- Bagged or loose household trash
- Pressure Treated Wood (usually has incisions on all 4 sides at regular intervals).
- Painted/Stained Wood

## GET CURBSIDE COLLECTION SERVICE

Residents and businesses of the Upper Napa Valley area may subscribe to convenient, regular, curbside solid waste (garbage, recycling, and compost) collection service provided by Upper Valley Disposal & Recycling (UVD&R).

## DEBRIS BOXES

Upper Valley Disposal & Recycling rents temporary debris boxes for large amounts of waste, construction & demolition, green waste, & recyclables.

## HAZARDOUS WASTES

**Residents** that generate hazardous wastes such as fluorescent lamps/tubes, latex paint, motor oil & filters, batteries, and sharps in sealed containers are accepted at Clover Flat Resource Recovery Park. Other types of hazardous wastes may be taken to the Hazardous Waste Facility at Devlin Road.



### PERMITS REQUIRED

**Business** that generate hazardous wastes are required to obtain a Hazardous Waste Generator Permit. Call Napa County Planning, Building & Environmental Services at 707-253-4471 for information.

### COLLECTION EVENTS


Upper Valley Waste Management Agency sponsors twice yearly hazardous waste collection events. Typically events are held in the Spring in St. Helena and the fall in Calistoga. These events are free for residents, businesses are charged a fee and appointments are required.

### DROP OFF AT THE HAZARDOUS WASTE FACILITY

Businesses that generate less than 220 lbs. or 27 gallons of hazardous waste per month may dispose of their waste at the Hazardous Waste Facility for a fee. Appointments are required.

# CALIFORNIA RECYCLING & ORGANICS LAWS

- **AB 341** requires recycling at all commercial sites that generate 2 cubic yards or more of solid waste per week and multifamily residential dwellings of 5 units or more.
- **AB 1826** requires businesses that generate organic materials to separate the material for composting.
- As of January 1, 2022, **SB 1383** mandates that all businesses and residents separate organic waste to be composted from non-organic wastes being sent to the landfill.

## TWO WAYS TO COMPLY WITH THESE LAWS

- 1 Self haul your separated materials to Clover Flat Resource Recovery Park & Landfill.
- 2 Subscribe to collection services with Upper Valley Disposal & Recycling.

### BUSINESS RECORD KEEPING REQUIREMENTS FOR SELF-HAULING WASTE

SB 1383 requires commercial organic waste generators (including landscapers) to maintain certain records if they comply with the organic waste collection service requirement by self-hauling their generated organic waste. (Title 14, Chapter 12, Article 3, Section 18984.9)

The records commercial businesses that self-haul must keep are:

- Delivery receipts and weight tickets from each entity receiving organic materials, including the amount of organic material in cubic yards or tons.
- If the organic waste is transported to a site that does not have scales or that employs scales incapable of weighing the waste received, the self-hauler is not required to record the weight of material. However, the self-hauler must maintain a record of the entity that received the organic waste.
