What are Contamination "Lid Flip" Audits?

SB 1383 (see the section below for more information) requires yearly audits of both commercial and residential containers to determine if recyclables and compostables are being properly diverted from the landfill. To put it another way, only recyclable items should be in recycling containers, only organic/compostable items should be in the compost or food waste containers, and only garbage items should be placed in the landfill containers. Items that are placed in the wrong containers are referred to as contaminants.

We call it a "lid flip" audit since we will be looking in your containers to find how much contamination is present. Tags will be left on carts, bins, and roll-off containers showing which contaminants were found from our audit. We will take pictures and send follow up emails to help businesses focus on where they can improve on in 2023.

Businesses were randomly selected to be audited this December and received a letter notifying them of the audit. There aren't any financial penalties for having contamination this year, but for containers that are more than 10% contaminated customers will need to be removed in order for them to be serviced. In future audits, fees may apply for contaminated carts and bins.

Are you Ready for SB 1383?


Composting your yard waste, food scraps, and food-soiled paper is now the law in California. The Short-lived Climate Pollutants Act (usually referred to as SB 1383) was passed in 2016, and enforcement will begin in January 2024. This law not only requires you to have the correct containers onsite, but to also use them correctly. Random "lid flip" audits will occur each year to ensure that residents and businesses alike are placing all items in the correct containers--not just the compost containers. Is your business ready for these changes?
